1. **Welcome and introductions** – 11 new members, successful MJOG Text messaging to all patients with mobile numbers; Terms of Conditions need to be reviewed (Philippa Cannings and Alan Harrison to action).
2. **Notes of last meeting** – briefly discussed; Alan Harrison thanked Trevor Rogers, the practice now puts in the occasional article in the local free magazines; Thornford, Yetminster, Longburton and Bradford Abbas.
3. **Practice Update** – Philippa Cannings (all matters discussed in the S.A.F meeting is confidential);

#### 4. CCG update – Keith Harrison

Keith explained the outline of the Patient Participation Group (S.A.F)

*Since April 2015 NHS England has required all GP Practices to establish a Patients Participation Group (PPG). This provides a regular forum for patients to discuss and inform the decisions made by their local GP Practice about how to continually improve its services. The main purpose of the PPG is to bring patients and the Practice closer together and the PPG fulfils the role as a 'critical friend' to the Practice, offering constructive feedback from the patients' perspective.*

7. **Newlands update** – Roger Marsh, Newlands have also been accredited with being a Dementia Friendly practice (January 2017)

Boots over 45's Health Checks – this has been poorly organised, staff now trained, 03/04/2017 Boots will now be able to offer this service

#### **AOB:**

1. Discussed how the S.A.F. could spread the word to the patients, already advertise on the practice website, Newsletter, at the Flu clinics , S.A.F. members in the waiting room/porch area to see patients during clinic time, text messaging.

Suggestions – S.A.F. in the waiting room discuss with patients, S.A.F. member outside Sainsbury's/Waitrose; Keith suggested all three practices combining.

Young members – possibly run a combined event with Bute and Newlands to engage our young patients.

2. Frank Brownsdon – asked what do the GPs want from the group/CCG?

Dr Miles would like to see the boundary of Somerset and Dorset removed, explained the difficulties that cross boundaries bring when referring a patient.

3. A suggestion was made that a leaflet informing the patients of all the different clubs/out-side health providers/leisure centre would be useful, especially for the new patients, new residents of Sherborne.

4. Keith suggested having a 'Steering Group' of a limited number of the S.A.F. group; Steering group will be pro-active with events/meetings – the remaining members of S.A.F. to meet every quarter to oversee and be updated with the current issues etc. The group did not confirm nor declined this idea.
